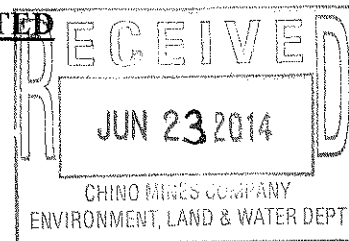

The Ground Water Quality Bureau of the New Mexico Environment Department (NMED) has reviewed the Golder Associates (Golder) revised submittal titled, *Groundhog No. 5 Stockpile Interim Remedial Action Work Plan for Additional Characterization and Controls, Hanover and Whitewater Creek Investigation Units* (Work Plan) dated June 3, 2014. The revised Work Plan was prepared by Golder on behalf of Freeport McMoRan Copper & Gold, Chino Mines Company (Chino). A draft Work Plan was submitted by Chino on April 28, 2014 in response to a NMED letter dated March 12, 2014 in which NMED requested that Chino prepare a draft work plan to further characterize and monitor the Groundhog No. 5 Stockpile seepage water quality. The comments on the draft Work Plan listed in the NMED letter dated May 15, 2014 have been sufficiently addressed in the revised Work Plan and response to comment letter (also dated June 3, 2014), and NMED approves this final version of the Work Plan.
